

## Overseas Challenge

### University Hospitals Coventry and Warwickshire (UHCW) Charity - Terms and Conditions

These are the Terms and Conditions of UHCW Charity.

The event is co-organised by a third party (Sky Blue Adventures) and their [Terms and Conditions](#) should be read in conjunction with those set out below.

It is a condition that all participants comply with both UHCW Charity and the terms and conditions of the third parties. By signing your consent to be contacted and your information stored by UHCW Charity you are agreeing to Sky Blue Adventures having access to your personal information. Sky Blue Adventures will only access and store your information in relation to the Mont Blanc Trip. Please be aware that by filling in and submitting the medical questionnaire, this will be assessed and stored by Sky Blue Adventures so that they can evaluate your fitness for this challenge. You are responsible for disclosing any medical conditions which may affect your ability to take on the challenge and it is your responsibility to acquire the relevant insurance.

We highly recommend that you take out holiday cancellation insurance, as your deposit is non-refundable and you will have to cover cancellation costs. If you withdraw in circumstances where recovery of cancellation charges is indemnified under your travel insurance policy, you agree that you will co-operate in the recovery of these charges from the insurers and any sums recovered under the policy will be paid to UHCW Charity. If the insurance company does not recognise your claim, you will be responsible for covering any cancellation charges borne by the Charity. You agree to raise all money using legal methods and complying with the fundraising code of practice.

It is a condition of booking this challenge that you must be insured against medical and personal accident risks (this must include helicopter rescue and repatriation costs). Recommended insurance suppliers are included in your event pack.

To take part in this event you must be 18 or over on the date of departure.

Your passport must have at least six months' validity from the date you return to the UK. It is your responsibility to apply for a visa, unless otherwise stated, before the event and at your own expense.

You participate at your own risk. If you are refused passage and/or entry/exit to or from any of the countries, any additional costs incurred are your responsibility.

You are responsible for making your own travel arrangements to and from the departure/return point in the UK. UHCW Charity will arrange airport transfer for the departure/return points in Switzerland. If you are not travelling on the suggested flights you will have to sort your own airport transfers.

For this challenge we require a deposit, as stated on the registration form. This fee is non-refundable once you have been accepted on the event. Please note that the registration deposit does not count towards any minimum sponsorship requirement.

By registering on this challenge you are pledging to raise the minimum sponsorship stated in the registration form and understand that it is the aim of this challenge to raise

as much above this amount as possible in aid of UHCW Charity. Please note that any gift aid which UHCW Charity may be able to claim will not count towards your minimum sponsorship requirement.

The registration fee and all sponsorship money should be made payable to UHCW Charity. Under no circumstances can money be raised for another charity or organisation.

You will state on your registration form the payment option that you will be agreeing to. If you withdraw from the event after you have paid your deposit, then you will still be liable to pay the amount stated in these terms and conditions:

You, or any member of your party, may cancel your place on the challenge at any time. The following cancellation charges will apply:

- More than 10 weeks before the start of the trip - deposit plus any other non-refundable items we have paid for on your behalf such as hotels, flights or guides
- 31-70 days before the start of the trip - 50% of the total trip cost plus any other non-refundable items we have paid for on your behalf such as hotels, flights or guides
- 30 days or less before the start of the trip - 100% of the total trip cost

You will also be required to bank the remaining sponsorship, at least up to the minimum sponsorship requirement. Please read Sky Blue Adventures Covid – 19 Cancellation Policy for amended refund/cancellation policy. You will be required to fill in a Coronavirus Health Declaration form 14 days prior the trip commencing.

Sponsorship money raised for one named event cannot subsequently be used against another event, even if the minimum sponsorship for the first event has been exceeded.

You understand and accept that itineraries, schedules and accommodation may change and other alterations may occur which are beyond the control of Sky Blue Adventures and UHCW Charity.

UHCW Charity shall not be liable for any injury, illness or death of any person or persons nor loss of or damage to any property nor for any indirect or consequential loss however arising other than for injury, illness or death arising as a direct result of any negligent act or omission of UHCW Charity its servants, agents or employees acting in the course of their employment.

UHCW Charity may at its sole discretion change routes or withdraw places on the challenge event if it is believed to be in its best interest to do so.

If you do anything to void your insurance, including not declaring a pre or existing medical condition, you are fully responsible for paying any and all associated costs including sponsorship.
